I fully understand and acknowledge that: (a) the activity of boating and the use of a dock slip have inherent risks, dangers and hazards and such exist in my use of a dock slip and related facilities at REGATTA LANDING DOCK SLIP ASSOCIATION, INC.; (b) my use of such equipment or premises may result in personal injury or property damage; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of REGATTA LANDING DOCK SLIP ASSOCIATION, INC., or by the negligence of other boaters, Dock Slip Licensees, or other Dock Slip tenants, accidents, the forces of nature or other causes.

By my participation in these activities and/or use of equipment such but not limited to a Dock Slip, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of REGATTA LANDING DOCK SLIP ASSOCIATION, INC., or by any other person, including myself. I also verify that I am in good health, will not boat under the influence of any drugs or alcohol of any kind, and am capable of pursuing the activity of boating, and that my participation in this activity is voluntary.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, discharge, hold harmless, defend and indemnify REGATTA LANDING DOCK SLIP ASSOCIATION, INC. and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my boating activities and use of a dock slip and related facilities at REGATTA LANDING DOCK SLIP ASSOCIATION, INC. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have at the present time or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of REGATTA LANDING DOCK SLIP ASSOCIATION, INC.

I acknowledge and agree that my use of a dock slip is subject to the covenants, conditions, restrictions, rules and regulations of the governing documents of REGATTA LANDING DOCK SLIP ASSOCIATION, INC. recorded December 14, 2017 in Official Records Book 5448 page 1098 of the Public Records of Collier County, Florida, as amended from time to time, including but not limited to any rules and regulations promulgated thereunder.

I HAVE READ THE WAIVER AND RELEASE AND BY SIGNING IT, AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE REGATTA LANDING DOCK SLIP ASSOCIATION, INC. FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
